ENTRY FEE: Intermediate and Novice Age Groups - \$10.00. Schoolboy and Cadets -\$20.00
USA Wrestling Cards required. (Checks MUST be made out to: Nassau NYS-USA Wrestling)
Wrestlers **Must** show USA Wrestling card at the weigh-ins. Wrestlers are encouraged to obtain their card on-line at themat.com. You may purchase a card on site at weigh-in for \$35.00. You **MUST** bring a copy of your birth certificate (non-returnable) in order to purchase card.

UNIFORM: Red and Blue singlets or a Red/Blue reversible singlet with briefs, wrestling shoes (no hard sole sneakers permitted). Protective headgear is not required, but is recommended.

RULES: International rules of FILA with USA modifications. Rules clinic will precede wrestling. Vertical Pairing or Round Robin Bracketing to be used. Separation by Club or Town.

BOUTS: (3) 2-minute periods w/30 second rest between periods. Tournament Committee may adjust this depending on number of entrants in order to complete the event in a timely manner.

AWARDS: 1st - 3rd Place medals

SCHEDULE: ALL WEIGH-INS WILL ARE ON THE DAY OF THE TOURNAMENT – NO ADVANCE WEIGH-INS
