(Wrestlers in 7th & 8th grade must wrestle in this division regardless of age on day of tourney)

Weight classes will be divided or combined to fill four man brackets, Round Robin style

NO 15 YEAR OLDS, 9th GRADERS, JV OR VARSITY EXPERIENCE

Individual Registration and Weigh-Ins on Wed., March 9th (Hauppauge HS Wrestling Room 6pm-8pm)

Weigh-Ins required for all wrestlers not submitted by their coaches (No Exceptions)

(A scale will be available at mat side if honor weigh-ins are challenged, 2 lb. allowance)

No walk-in entries, weigh-ins or USA Cards sold on Saturday

“Wrestlers with any form of Skin Condition or Rash will not be permitted to wrestle”

Entry Fee: \$20.00 payable to the Hauppauge Wrestling Club

All proceeds go to the Hauppauge Wrestling Club, (Tyler Lynde/Ken Lesser Scholarship Fund)

Awards: Custom Die-Cast Medals for 1st, 2nd, 3rd, and 4th place finishers in each weight class with Bracket Sheet to Champ
