Bantam and Novice 10:30 am check in. To check in all you have to do is make sure your name is in the correct Brackets posted on the walls. If you have a problem contact the head table.
- ⇒ Entrance to the tournament will be in the **REAR OF THE SCHOOL**
- ⇒ General Admission: Adults \$3, Children \$1, (children under 3 years old are free)
